Items

1. Members were welcomed to the fifth meeting of the Forum. The Chair introduced the agenda items and passed on the apologies of the Minister, who was unable to attend.
2. The agenda and the minutes of the previous meeting of the Forum were agreed.
3. The Chair provided a brief outline of progress on the Responsible Business agenda, referring to the publication of the Directive on Corporate Sustainability Due Diligence, the entering into force of the Ecodesign for Sustainable Products Regulation and progress on the proposed regulation prohibiting products made with forced labour on the Union market.
4. The Chair introduced a presentation on the Corporate Sustainability Reporting Directive, providing an overview of the Department's work on implementation, the development of standards by the European Financial Reporting Advisory Group (EFRAG) and the European Commission and ongoing stakeholder outreach efforts. Forum members raised questions about enforcement and discussed the availability of supports.
5. The Chair introduced a presentation on the Carbon Border Adjustment Mechanism. The presentation outlined the policy's place within the European Green Deal and the requirements for businesses, and addressed Forum members' questions.
6. The Chair introduced a presentation by Ms Nessa Whelan of the UN Global Compact Network on the establishment of a Country Network for Ireland. Ms Whelan outlined the background of the Sustainable Development Goals and the opportunity for businesses to participate in the Global Compact, as well as plans for the launch of the Country Network for Ireland, to be held on 28th November 2024 at the An Post HQ in the Exo Building in Dublin.
7. In response to queries from Forum members the Chair committed to provide copies of the presentations delivered, the voluntary reporting standard for SMEs under development by EFRAG and a paper prepared by the Irish Government Economic and Evaluation Service on the cumulative impact of measures to improve working conditions in Ireland.
8. The Chair thanked attendees and concluded the Forum.
