Item 1: Welcome and opening remarks

- The Minister for ETE, Peter Burke TD, opened the meeting and welcomed all attendees both in the room and online.
- Minister Burke acknowledged that all Forum members are currently working hard to analyse the impacts of the trade tariffs announced the day before and that it is important that clear, calm messaging is sent to all networks.
- The Secretary General of DETE, Declan Hughes, informed the members that the
 Department is currently developing a new Statement of Strategy which will shortly
 be open for consultation and Forum members will be asked to send in any views or
 observations they have on this.
- The minutes from the Enterprise Forum meeting of 16 October 2024 were approved.

Item 2: Programme for Government

This is the first Enterprise Forum meeting since the new Programme for Government
was launched and Minister Burke spoke of the priorities that will be of benefit to the
Enterprise sectors, such as the important role the SME Test plays in future legislation
and decisions.

Item 3: IE/EU trade relationship with the USA.

- The Assistant Secretary of Trade Division spoke on the announcements of tariffs made by the US administration on 2 April.
- Minister Burke invited each Member to participate in a discussion, to include their initial economic analysis and findings, along with any communications from their own members.
- Many Members noted that the tariffs will pose challenges to some businesses in Ireland and the impact is still being assessed, with many businesses asking very practical questions.
- It was noted that the Trade Forum is being held on 4 April, and the messaging here will be important.
- Members were asked to share with DETE any issues/concerns that arise.

Item 4: Better Regulation and Burden Reduction

 Officials from the Department's Better Regulation Project Unit, Small Business Unit and Company Registration and Regulation Policy Unit spoke to Members about the Government's commitment to improve Ireland's competitiveness by making it easier

- to do business in Ireland. To help with this, DETE is looking at ways to reduce any unnecessary red tape, bureaucracy and administrative burden on businesses.
- Members were involved to share with DETE any ideas they have to simplify administrative processes for business.
- Members were informed of the successful application of the SME Test since its introduction and plans to encourage its use further when Departments are developing new policies and legislation.
- The National Enterprise Hub (NEH) has been successful in bringing together information and resources on government supports from different Departments and state agencies.
- Members also received information on the European Commission's focus on simplification and burden reduction at EU level, following on from the Letta and Draghi reports published in 2024. The Commission's recently published work programme for 2025 has indicated the intention to bring forward a number of so-called "Omnibus" packages and simplification proposals in the context of strengthening EU competitiveness, such as the proposal to change to the scope and timing of both the Corporate Sustainability Reporting Directive (CSRD) and the Corporate Sustainability Due Diligence Directive (CSDDD) requirements for certain categories of companies. This proposal would reduce the reporting and compliance burden on those businesses within scope.

Item 5: Update on Responsible Business Initiatives

- The Assistant Secretary of Trade Division reiterated the importance of keeping the overall Responsible Business initiatives streamlined and packaged together.
- It was acknowledged that the European Commission is working with Member States on these initiatives.
- The Responsible Business Forum, a sub-group of the Enterprise Forum, is planning to hold its first meeting of 2025 shortly. Members will be kept informed and invited to attend once the date has been set.

Item 6: Ireland's Second National Implementation Plan for the Sustainable Development Goals (SDGs) 2022-2024

- An official from the Department's Data and Evaluation Unit gave a presentation on Ireland's implementation of the Sustainable Development Goals.
- The UN Agenda 2023 is made up of 17 SDGs, with 169 SDG targets, in the areas of economic growth, social inclusion and protection of the environment. The 2030 Agenda is voluntary and not legally binding, but every country has agreed to implement the SDGs.

The Department of the Environment, Climate and Communications has overall
responsibility for promoting the SDGs and overseeing their coherent implementation
across Government. They have published two National Implementation Plans to date
and all 169 SDG targets have been mapped against national policies.

Item 7: AOB

National Disability Strategy

- Brian Walsh from the Department's Retail Forum and Locally Traded Enterprises Unit informed the Members that the Department of Children, Equality, Disability, Integration and Youth is currently overseeing finalisation of the next National Disability Strategy. The strategic objectives are being considered under five key thematic pillars and DETE leads on the Employment Pillar, along with the Department of Social Protection.
- DETE are proposing to form a sub-group of the Forum to provide a platform for a
 more structured consultation and engagement with employers on disability
 employment. It would serve as a means of discussing how best to support
 employers to employ people with a disability and to hear directly from employers on
 their experiences and discussing any concerns.
- Further details will be communicated in due course including membership and meeting arrangements
